1. RICHARD CASE NAGELL, AKA JOE CRAMER, JOE KRANE, ROBERT C. NOLAN, 201-746537, WELL KNOWN TO LNERGO. SUBJECT ENTERED US ARMY 1948 HONORABLY DISCHARGED CAPTAIN 1959. DURING KOREAN CONFLICT RECEIVED MANY CAMPAIGN AWARDS. SOLE SURVIVOR AIRPLANE CRASH NOVEMBER 1954, SEVERAL SUFFERED FACIAL DISFIGUREMENT AND GIVEN/PSYCHIATRIC EXAMINATIONS. MOTHER, BROTHER, FORMER WIFE, AND FRIEND OF NAGELL ALL CONSIDER HIM TO BE MENTALLY DISTURBED. NO INDICATION NAGELL INVOLVED IN ESPIONAGE, COMMUNIST PARTY, OR FAIR PLAY FOR CUBA COMMITTEE ACTIVITY.

2. IN 1964 LETTER TO LNERGO NAGELL REFERRED TO ANOTHER LETTER RE OSWALD (201-289248) WHICH HE ALLEGEDLY WROTE TO LNERGO IN 1963. LNERGO FILES CONTAIN NO RECORD OF 1963 LETTER. NAGELL IMPRISONED ON BANK ROBBERY CHARGE AND HAS ATTEMPTED SUICIDE. Document Number 1125-984
