<p>1. Transmitted herewith is a copy of the PRQ Part II on UNRUMBLE/2. Under separate cover is transmitted a copy of the PRQ Part I. UNRUMBLE/2's 201 number is as indicated above.</p> <p>2. Background.</p> <p>UNRUMBLE/2 is a Cuban medical student in Paris. He had four years of medical study in Cuba prior to arriving in Paris in late 1961 to complete his studies. He is currently interning at the Hospital of the Cite Universitaire here and is seeking to complete his courses this Spring. He is now a qualified Doctor. UNRUMBLE/2 has a young wife and one child, a boy, born early this year. UNRUMBLE/2 was first brought to the Station's attention by an ODAICD officer whom UNRUMBLE/2 visited upon occasion to discuss the Cuban situation. He was monitored over a period of about six months by this officer and other Station agents and was introduced to a Station officer in June 1962, shortly after which he was recruited.</p> <p>3. Operational.</p> <p>Since his recruitment, UNRUMBLE/2 has been employed by the Station in two major fields: Propaganda work and as a penetrator of the Cuban student community in Paris. He has done quite well in both. In the area of CA activities, UNRUMBLE/2's major accomplishment, insofar as the Station is concerned, has been to keep the Maisons de Cuba at the Cite Universitaire out of the control of the Cuban Embassy. There are many national houses at the Cite, most of which reflect the political orientation of the government concerned. UNRUMBLE/2, by dint of an aggressive personality, political acumen, organizational ability, and hard work has managed to keep the Maisons de Cuba an active center of anti-Castro activity, much to the chagrin of the Cuban Embassy which has tried continuously to take it over. In performing this task, UNRUMBLE/2 has also demonstrated good political sense in choosing influential supporters within the French administration of the Cite. From the Maisons de Cuba, UNRUMBLE/2 has sent a steady stream of propaganda material to Cuban and other Latin American students and residents of Paris, some of this his own effort and some supported by the Station. UNRUMBLE/2 has demonstrated a knack for public speaking and has been called upon on many occasions, as the President of the Maisons de Cuba, to publicly express the anti-Castro Cuban viewpoint.</p>

b. In other specific CA type activities UNRUMBLE/2 has performed effectively as an organizer and agitator. He was sent by KUARK to the Helsinki Youth Festival in 1962 where he contributed to disruption in the Cuban delegation; he organized demonstrations at the Cuban Embassy in Paris during the Day of Pigs landing and during the October Missile crisis. He has participated in black letter operations targeted against Cuban officials here and in black mailing operations in support of Headquarters requests.

5. On the plus side of the ledger, UNRUMBLE/2 has not produced many intelligence reports. This, however, has been due more to lack of access than lack of effort on his part. He has contributed occasional reporting thru visitors and refugees from Cuba and occasional reports on conditions and personality differences within the Paris embassy. He has accepted our requirements and has attempted sincerely, we feel, to fulfill them within his limitations. Given a situation with access to information, we feel that he could be an excellent reporter as he is intelligent and thorough in what he does.

6. Thru his position as leader of the anti-Castro student community in Paris, UNRUMBLE/2 has provided considerable CK/CI information to the Station. He submits weekly written reports on movements and activities of non-official Cuban and Latin American students, of which there are many, in Paris. He performs investigative tasks as requested and has contributed a considerable body of information to Station files on Latin American individuals here.

7. Assessment

To begin with, UNRUMBLE/2 has never been a paid agent in the controlled sense. He is basically a Cuban Nationalist, anti-Communist and anti-Castro, but also anti-American - control-of-Cuba. He believes and hopes for a Cuban solution to the Cuba problem but recognition that assistance, or at least approval, from the United States will be necessary to effect the liberation of Cuba. Thus, he has been a collaborator and not a paid informant. This collaboration has not been given without self-interest. UNRUMBLE/2 has been for some time the representative for France of Manolo RAY's "JURE" organization and he has hopes of a political future within a liberated Cuba. He has been quite forthright in stating that should the goals and general activities of the "uncontrolled" Cuban exiles - such as, in his opinion, the RAY organization - come into conflict with those of the United States, forcing a choice of collaboration upon him, he would definitely stay with the Cuban approach. Fortunately, this choice has not yet been placed before him, but he has told the writer that he would be frank in stating when he believed such a choice had to be made. I believe that he is being truthful in making this pledge.

8. Unfortunately, UNRUMBLE/2 is suffering from a malaise which has affected several of our Cuban assets in recent months - disillusionment. From this stems his decision to leave Paris. He has stated that if there appeared to be a reasonable chance of overthrowing Castro within the near future, he would stay in Paris to collaborate with KUARK, since this is the area in which he feels he could contribute most in such a situation. However, he has seen the Day of Pigs and the October Crisis come and go and now feels that Castro's position is stronger than ever and that there is no solution acceptable to him in the offing. He also has his wife and child to consider, along with his own future. He has, therefore, decided to leave Paris for Latin America to practice his medical profession. This is certainly not to say that UNRUMBLE/2 is abandoning the fight. He still strongly believes that Communism, whether espoused by Castro or someone else, is the number one menace to Latin America and must be eradicated wherever possible. I believe, therefore, that his expressed interest in collaborating with KUARK in the future in Latin America is a sincere one. It should be stressed, however, that UNRUMBLE/2 is possessed of a strong personality, is not without self-interest, and has a pride which must be handled with tact.

handled with tact. Assuming this, UNQUOTE/2 can be a productive and trustworthy agent.

9. During the period of his collaboration with UNDP/PL2/2 has been paid the equivalent of US \$100.00 per month. This has not been outright salary but has been given to him to support his anti-Castro activities. I believe that part of it has gone for those activities, and very seldom has he requested additional operating expenses. UNDP/PL2/2 is very security conscious for a Cuban and we believe that he is comparatively clean insofar as connections with RUEANK goes. As the overt and very vocal leader of the anti-Castro element in Paris he had naturally become the target of various accusations, including collaboration with "the Americans", from the Cuban embassy and pro-Castro Cubans here, but these accusations have never been proven. Meetings with him have been clandestine and he has readily recognized and accepted the necessity for this.

10. UNQUOTE/2 has, at times, shown bad judgement, reflecting his desire for personal credit in the anti-Castro struggle. He has, during periods of crisis such as the October Missile crisis, made public statements which could have endangered other operations of which he was writing. He has, therefore, been compartmentalized from other operations as much as possible. I believe, however, that UNQUOTE/2 has matured considerably during the past year and a half and has lost some of his youthful fervor, but he retains a considerable vanity and desire for acknowledgement of his accomplishments. He will, in short, require tactful but firm guidance.

11. Present status

As things now stand, UNRUE/LB/2 has been informed that there is a possibility of future collaboration with IIEAPK in Latin America, specifically in Peru, and he is trying to find out more about the assignment mentioned in Reference A. Two organization which is mentioned in UNRUE/LB/2 is the

humanitarian efforts of the prominent L'Abbe Pierre of France. Station traces
on the Association are negative, and on L'Abbe Pierre indicate no communist
connection. Headquarters traces may reveal more information on both and we
would appreciate Headquarters traces for both Lyon and Paris.

12. As regards URRURE/2's projected location of assignment in Peru, we presume that it would be Huancayo, which, again, we presume to be a geographical section of Lima, since URRURE/2 has been told that the Association would pay his "transportation to and lodging at Huancayo Lima". From the nature of the Association, it would appear that Huancayo is a poorer section of the city. URRURE/2 is at present attempting to discover just what his work conditions, such as hours, would be and the category of his prospective patients. As soon as these details are available we will forward them to you.

13. We realize that the above leaves much to be desired from your point of view in determining the potential future value to you of UNRUEBLE/2, since we really do not yet know just what his job will be. We hope that additional details will become available shortly. UNRUEBLE/2 hopes to leave Paris about the end of May, dependent, of course, on what job he finally decides upon - the Association offer being one of several he has in mind. We would, therefore, appreciate your estimate of your interest in having UNRUEBLE/2 accept the Association offer. If your estimate is positive, we could then place UNRUEBLE/2 on, possibly, a six month probationary period working for you - he would require some kind of incentive of this type to accept in the first place. Gives any kind of access at all we believe that he could work out well. In any event, we hope to have more details per paragraph 12 above by the time this dispatch reaches you and will cable them as received.
