1. BACKGROUND. PRESS, WIRE SERVICES TODAY REPORT ARREST IN LÉOPOLDVILLE, CONGO, TWO SOV DIPLOMATS, MORIS KORNBLIT, COUNSELOR SOV EMB., VYRY NYAKOTENKH, PRINCIPAL ATTACHE, AFTER OBTAINING DOCUMENTS, PROVING SOV SUPPORT FOR CHRISTOPHE GOMBYE, FOLLOWER OF LATE LUMUMBA, NOW TRYING FORM CONGO EXILE GOVT IN BRAZZAVILLE, FOUND IN THEIR POSSESSION. SOV GOVT NEWSPAPER IZVESTIA, MOSCOW, 20 NOV, DENOUNCED "SHAMEFUL PROVOCATION" AND "BANDIT METHODS". CONGO GOVT EXPECTED TO SUSPEND OR BREAK DIPLOMATIC RELATIONS WITH SOVS, CZECHS.

2. GUIDANCE. MAXIMUM PUBLICITY ABOVE EVENT, PLUS FURTHER DEVELOPMENTS CASE. URGENTLY DESIRED. DISREGARD HOLD PARA ONE REF., FOR ALL FACTS ALREADY IN PUBLIC DOMAIN. ALL TREATMENT SHOULD DISPLAY ALLEGED MANHANDLING OR BEATING SOV OFFICIALS AND DROPPED HYDRAULIC PROPULSORIES LIKE SULPHUR ACID PLOT
