1. HIS UNDERSTANDING OF AGREEMENT REACHED BY BOTH ORSAFT AND ORSAFT AT TAXCO WAS 100% A MONTH IN LIEU OF RETIREMENT TO BE PUT IN SAVINGS ACCOUNT IN PERIOD OR PAID DIRECTLY TO ORSAFT. ORSAFT ELECTED BE PAID DIRECTLY. IF ILLIENED RETIREMENT EQUAL TO PREVIOUS EMPLOYERS' PLAN 100% SHOULD BE STOPPED OR CUE BACK TO AMOUNT NECESSARY TO COMPENSATE FOR DIFFERENCE BETWEEN ORIGINAL PLAN AND ILLIENED PLAN.

2. RE PERM 2 REF: THIS PLAN REVISED BY BRINKING WHO OFFERED PAY COSTS. APPEARS BRINKING NOW TRYING PASS THESE EXPENSES TO KIRK WHO WOULD NOT ADVISED OR CONSIDERED. WHEN ORSAFT FIRST MENTIONED THIS PLAN BRINKING ASKED WHO WOULD PAY AND ORSAFT SAID BRINKING. ORSAFT TOLD BY BORNHOLD KIRK WOULD ONLY PAY COST TOURIST TICKETS FOR FAMILY NO HOTEL EXPENSES.
