In essence, Billings advised to the best of his recollection he does not recall refusing to return a handwritten code list back to Sergeant Garland Dale Fore, Madera County Sheriff's Office Chowchilla, California, that he received from him in the early part of January or February of 1979. Additionally, he does not recall making any statements that the codes were classified government codes and listed as top securit He then advised that the statements on page 7 and 8 were not accurate.
