By communication marked "Secret" dated 8/26/58, [redacted] H & R Section, [redacted] advised that they received the following information from a usually reliable source. Information is prefaced with the following statement: "In view of the sensitive means through which we acquired it, it is requested that the FBI take no action which might compromise our source." [X]

Communication states that PEDRO LUIS DIAZ LANZ, also known as PEDRO LUIS DIAZ, a Cuban born November 8, 1926 at Havana, is a pilot, courier, and possible agent for FIDEL CASTRO. DIAZ is reportedly associated with REINALDO BLANCO HERNANDEZ and ALBERTO EUSEBIO MOJENA who are Cubans and not further identified. Jamaican police believe that these three individuals operate from Ft. Lauderdale, Florida. [X] (u)

DIAZ passed through Palisades Airport, Kingston, Jamaica, on May 5, 1958. On July 17, 1958, DIAZ arrived at the Palisades Airport, piloting a Cessna aircraft, #M5213D with BLANCO as a passenger. The [redacted] (u)
