2. HERNANDEZ SAID THAT "OUR OWN SPECIAL GROUP" IN CUBA WHICH
MONITORS CORU ACTIVITIES HAS REPORTED THAT CASTRO AND ANTONIO
VECIANA, WHO HAS ACCESS TO EXPLOSIVES IN VENEZUELA, ARE ALREADY
IN VENEZUELA AND ARE PREPARING TO CARRY OUT SABOTAGE AND TERRORIST
ACTIONS. THIS SPECIAL GROUP OF THE CUBAN GOVERNMENT BELIEVES THAT
CASTRO AND VECIANA WILL ACT TOGETHER.

3. HERNANDEZ ALSO SAID THAT THE CUBAN GOVERNMENT WAS TOLD BY
U.S. STATE DEPARTMENT OFFICIALS ABOUT VECIANA'S PRESENCE IN VENEZUELA
AS THEY BELIEVE THAT HE IS A MEMBER OF CORU ACTIVELY INVOLVED IN
CORU ACTIVITIES. ACCORDING TO HERNANDEZ, THE U.S. OFFICIALS
BELIEVE VECIANA IS WAITING FOR SOMEONE TO HELP HIM CARRY OUT
TERRORIST ACTIVITIES IN VENEZUELA.
