Synopsis:

Subject organization has its headquarters and bookstore at Juarez 682, Guadalajara, Jalisco, Mexico. Attorney ARTURO RIVAS SAENZ is acting as Director of this organization. Its premises were inaugurated on October 25, 1958, with one of the speakers being BORIS A. KAZANTSEV, First Secretary of the Soviet Embassy, Mexico City. The announced purpose of the organization is the exchange of cultural material to improve Mexican-Russian relations and understanding. About two hundred people attended the inauguration. Names of some of the people who attended set out. At a meeting held November 11, 1958, the work of subject organization was discussed.
