(U) LUIS POSAD CARRILES [redacted] CONSIDERED A VERY
RELIABLE SOURCE. HE IS KNOWLEDGEABLE RE THE MOVEMENT IN
CUBAN COLONY, MIAMI, AND [IS A RECOGNIZED EXPERT IN THE FIELD
OF EXPLOSIVES.] PREVIOUS INVESTIGATION REFLECTS THIS INDIVIDUAL
WAS IN CHARGE OF A MILITARY TRAINING CAMP OPERATED
IN POLK COUNTY, FLORIDA IN SUMMER OF NINETEEN SIXTYFOUR BY
ANTI-CASTRO ORGANIZATION KNOWN AS JUNTA REVOLUCIONARIA
CUBANA (JURE). [HE WAS ALLEGEDLY INVOLVED IN A PLOT HEADED
BY ROBERTO ALEJOS ARZU, WEALTHY GUATEMALAN EXILE IN MIAMI
TO OVERTHROW THE PRESENT GOVERNMENT OF GUATEMALA. THIS PLOT
WAS ABORTED IN MAY, SIXTYFIVE BEFORE IT GOT UNDER
WAY.]

HUNDRED SIXTY DOLLARS FOR GRENADES BUT DELIVERED ONLY
FORTY. SUBSEQUENTLY BORGES ASKED SOURCE TO GO TO DIAZ
AND EITHER PICK UP OTHER TWENTY GRENADES OR THE ONE HUNDRED
