Reference report of Special Agent JOHN E. Mc HUGH, 11/13/61 at Miami.

On December 14, 1961 RICARDO MORALES NAVARETTE, brother-in-law of the subject, 541 S.W. 7th Street, Miami, Florida, advised that the subject is now in a training camp sponsored by the CIA. MORALES also made available a notice forwarded to the subject by Local Board #46, indicating that the subject was not found to be acceptable by the armed forces. He was classified 4-F. He was issued a classification card dated November 20, 1961, reflecting the 4-F classification.

On December 14, 1961 [redacted] CIA representative in Miami, advised that his agency had an operational interest in the subject and that CORNILLOT is now under the control of CIA. [redacted] stated that if the services of CORNILLOT are not utilized, the Miami Office of the FBI will be immediately advised.

In view of the above, no further investigation contemplated at the present time in an attempt to locate the subject for the approved Bureau interview.
