The departure of Cline from his current job has been the subject of some publicity, and it has been implied that he asked for a field job because of differences with Admiral Raborn. The rumors which have circulated indicate that there is some good basis for this allegation. Cline, who has largely been responsible for preparation of intelligence estimates, reportedly has not been able to work in harmony with Raborn. Villiam Harvey, ex Bureau Agent, currently in charge of CIA's office in Roma, very likely will be transferred to CIA Headquarters later this year. Information received indicates that Cline will be succeeded by Jack Smith who has been serving as one of Cline's So far no name has been mentioned as a successor assistants Harvey.
