The Liaison Agent has been informed that Ray Cline, Deputy Director of Intelligence, is slated to become the head of CIA's operations in [redacted]. The assignment in [redacted] is currently being handled by Gordon Stewart, who will be transferred to CIA Headquarters. The departure of Cline from his current job has been the subject of some publicity, and it has been implied that he asked for a field job because of differences with Admiral Raborn. The rumors which have circulated indicate that there is some good basis for this allegation. Cline, who has largely been responsible for preparation of intelligence estimates, reportedly has not been able to work in harmony with Raborn.

William Harvey, ex Bureau Agent, currently in charge of CIA's office in Rome, very likely will be transferred to CIA Headquarters later this year.

Information received indicates that Cline will be succeeded by Jack Smith who has been serving as one of Cline's assistants. So far no name has been mentioned as a successor to Harvey.
