Reference is made to [Bureau Source] information which indicated that the subject was possibly working for the Cuban Intelligence Service. Pursuant to instructions, this matter was discussed with [redacted] Central Intelligence Agency (CIA), on October 10, 1961, for the purpose of seeking additional identifying data concerning the subject. On October 13, 1961, [redacted] stated that CIA has been unable to develop any further identifying data. With regard to the traffic which involved the captioned name, [redacted] stated that it was believed to be radio communications of Cuban Army Intelligence prior to the abortive invasion of April, 1961.
