The foregoing was furnished to the Liaison Agent on November 29, 1963, by Austin Horn, CIA, who inquired if the Bureau had any objection to CIA initiating an approach of the subjects through the use of

OBSERVATIONS:

It is the opinion of the Liaison Agent that CIA does not have a strong foundation for initiating an approach as indicated. The Agency could be on a fishing expedition and we may find it desirable to object to CIA's proposed action in the absence of additional information. We also should bear in mind that the Bureau is free to consider the use of the lift we felt this operation should be handled by the Bureau.

ACTION:
