- ODENWY SAYS THEIR FOLLOW-UP INVESTIGATION OF OSWALD'S ACTIVITIES HAS PRODUCED "REALIABLE INDICATIONS" THAT HE WASH IN NEW ORLEANS ON 19 SEPTEMBER 1963 REPEAT 19 SEPTIMBER 1963.
