- Q: This was because we didn't have info.


Q: But wife's routing instructions were on those materials.

Rumors to effect that HQS had located photo of LHO

- H: Doesn't recall; doesn't recall receiving photo;  
 There is a photo in LHO's M.I. file recd. from Navy on 11/23.

- H: No memory discusses w/ respect to this case.

X. Scott wanted us to do thorough job; we did. Same w/ HQS.  
 Did a full, honest, thorough job.

- H: Not surprising that HQS didn't send photo - wasn't important enough.

- H: Both believe that it is absolutely unlikely that LHO had a professional connection w/ Roselli because of nature of contact.
