1. Please advise SMABOVE that we have read the results of the ROGALSKY and HERZOG interviews with interest. We concur that the information which was obtained adequately answers a number of our questions concerning them and probably reflects a true picture of their relationships with AEVALIANT 1. As these relationships appear to be innocent and in the absence of any other indications that the ROGALSKY couple and HERZOG are affiliated with Soviet Intelligence, we feel that their particular cases can be considered closed.

2. We are still interested in receiving the results of other SMABOVE interviews of selected contacts of AEVALIANT 1 and, of course, wish to be kept current on developments with regard to HITSCH.
