1. REF CABLES PROBABLY REFER TO SAME EXPEDITION.

2. LOCAL LNERGO NOTIFIED STATION 24 OCTOBER THAT LMPURE CONSUL MERIDA MEXICO REPORTED REF GROUP 19 OCT ALLEGEDLY LEFT FROM PROGRESO MEXICO FOR GUATEMALA (NOT CUBA AS SURMISED REF B) YACHT "EL AMIGO." TWO UNIDENTIFIED MEXICANS FORCED GO ALONG. MEXICANS CHECKING TO DETERMINE IF THEY OWNERS OF BOAT.

3. SEVERAL MEXICO NEWSPAPERS CARRIED STORY 24 OCT RE PRESENCE <sup>PRE</sup> REF GROUP IN MERIDA. <sup>ON</sup> YACHT "EL AMIGO" <sup>WHICH HIJACKED</sup> HAS BASIC RANGE 560 MILES BUT SPARE FUEL IN DRUM OBSERVED ON DECK. MEXICANS ESTIMATE BOAT WILL HAVE TO REFUEL NEAR BELIZE BRITISH HONDURAS.

4. LOCAL LNERGO FURNISHED FOLL INFO RE PERSONS INVOLVED SUSPECTED YACHT HIJACKING:

A. FRANK ANGELO FIORINI TOLD LNERGO SOURCE THAT HE AND GROUP PLANNED GO GUATEMALA TO CLEAN OUT ANTI-GUATEMALAN GUERRILLAS AND SET UP BASE OF OPERATIONS FOR OPS AGAINST CUBA. FOR THIS WOULD BE PAID 1000 DOLLARS PER MONTH AND 10,000 DOLLARS ON COMPLETION OF MISSIONS. HE CLAIMED TWO OF MEN WHO ARE

B. ALSO IN ABOVE GROUP AKA: MAX GORMAN WHO IDENTIFIED BY  
 LNERGO AS MAXIMILIANO GONZALEZ. GORMAN WITH ALLEGED WIFE SHERYL  
 CROSSED INTO MEXICO AT MATAHOROS 22 AUGUST IN BLUE 1968 CAMARO  
 WITH FLORIDA PLATES 32-3487. CAR PAPERS SHOWED DONALD CLAUD  
 OWNER. LNERGO IDENTIFIED CLAUD AS FORMER MARINE WITH MARINE  
 CORP TATTOO ON ARM. THEY POSSIBLY ACCOMPANIED BY RAYMOND AND  
 LYNN BANNISTER WHO WERE LISTED MATAHOROS BORDER RECORDS AS  
 CROSSING 22 AUGUST AS PASSENGERS IN 1968 CAMARO. THEIR NAMES  
 LISTED CONSECUTIVELY AFTER GORMANS AND CLAUD.

C. FIORINI SAID GROUP WOULD SELL THE CAMARO IN MEXICO  
 TO RAISE MONEY FOR HIS OPERATIONS. SINCE NO WOMEN OBSERVED ON  
 YACHT LNERGO BELIEVES SHERYL IDENTIFIED AS WIFE OF MICHAEL  
 SCHLEGELER MIAMI BAR OWNER) AND OTHER UNIDENTIFIED WOMEN PROBABLY  
 TOURING MEXICO. THEY WERE TO GET IN TOUCH WITH MEXICAN WHO IS  
 TO SELL THEM DOCUMENTS AUTHORIZING SALE OF CAR IN MEXICO.

D. OTHER IDENTIFIED MEMBERS FIORINI GROUP ARE FRANK  
 BONELLI WHO ENTERED MEXICO AT CIUDAD MIGUEL ALFONSO ON 30 AUGUST.
