In answer to request of Gregory O. SARGAN, the following is a composite of information from **EARL P. HILL (TEPMU)** (INFO B) and **VERNE L. MURKIN (TEPMU C)** concerning Item A.

1. Description of subject between 35 and 40 years old, about 6 feet tall, rather bald, small mustache, very strong and vigorous, fine white teeth, Jewish. Speaks quite good English. He is married and has one 9 or 10-year old daughter. He has a sister in New York who is a naturalized American citizen. **[REDACTED]** says subject speaks well, loves fine music, has an impressive library, reads continually and paints very well.
2. Early during the war he was deported as a Jew to a German concentration camp (tattooed prisoner's identification number on right forearm—974), where he spent several horrible years and survived only by luck. Since 1945 he has spent most of his time in Indochina and was apparently in intelligence or related fields most of the time. **TEPMU** reports that the first **SCAMM** rep in **Hanoi** 1950-51 was snared in by an offer from subject to mount combined operations and was shortly afterwards declared persona non grata by the French.
3. Subject took part as a civilian in the Atlanta Operation, etc., according to one report, went in with vast sums of money to make propaganda, buy off the opposition, etc. **[REDACTED] (Item B)** and **MURKIN (Item C)** considered Item A's accomplishment in Central Viet Nam among the few notable achievements in that area, particularly in respect to his contribution to the Vietnamese pacification program which he coordinated throughout the course of Operation Atlanta.
4. Subject is an old friend of (Col.) **JANG GUTTENAI**, former chief of **SEMA**. He was for a time (June-August 1955) in the National Security Division, during which time he proposed to **VILLENS** joint operations—pool resources and experience (similar to French proposal, above) but **VILLENS** refused, considered proposal preposterous moreover.
5. March-April 1954 subject approached Station and **UMSID** for military support for program to support nucleus of a people's militia (**guerilla civile**) in the **Ha Long** area. Information and correspondence on this proposal will be sent upon request.

6. In February-March 1955, subject was sent by the French on a special mission to Poland and East Germany to attend a conference.

7. Subject claims that while working for DDCI he organized an operation [REDACTED], who later asked that he be removed from Algiers. Subject stated that [REDACTED] wanted to get rid of him for "political" reasons approximately 19 December 1955.

8. At present subject is [REDACTED]
at Paris, France, as of 26 December 1955. He apparently intends to resign. He has been here last 17 May.


