3. [S] LAYCOCK-1 SHOULD NOT BE BELIEVED RE ARRANGEMENTS FOR
PACKAGE LAUNCH MATERIALS, AND IF TOPIC ARISES SHOULD REFER SUBJECT TO LATER
DISCUSSION WITH PEPRIDE CO. DETAILS FOLLOW THROUGH KUDUS/D CHANNELS.

4. ALTHOUGH RECOMMENDED STRONGLY PREFERRED, IF INTEREST ONLY
ALTERNATIVE, STATE CANCER GUARANTEE SUBJ PEPRIDE RESIDENCE STATUS BUT CAN
ASSIST PEPRIDE EFFORT AS PAROLEE IN WHICH CASE KUDARK RESPONSIBLE FOR HIM.
TEND IF HIS PERFORMANCE AND VERIFICATION BONA FIDES AFTER SECRET WARRANT,
HE MIGHT SECURE RETURN HOME AND ESPECIALLY CITIZENSHIP. KUDARK NOT ABLE
