1. POLITICAL MATTERS FOR DISSEMINATION WERE SOVIETS RE CURRENT USSR ECONOMIC DIFFICULTIES. AS BODIED REF, ITEMS INTENDED AS OPERATIONAL AID FOR ASSESSMENT AND EVALUATION SOVIETS, AND AS MEANS HOW DOUBT RE FOREIGNS ABILITY DEAL WITH ECONOMIC PROBLEMS. RECIPIENTS SHOULD NOT MEMORIZE ALL ITEMS BUT SELECT ITEMS APPROPRIATE FOR OWN USE. REPORT POSSIBLE CONTACTS VIA OPS CHANNELS. HQS WILL SCREEN FOR VALUE.

2. WESTERN PRESS (REUTERS VIENNA 16 NOV) REPORTED STRIKE BY WORKERS KRIVOI ROG. REASONS WERE BREAD SHORTAGE AND DEMAND FOR WAGE INCREASES MEET RISING FOOD COSTS. SINCE NO ANNOUNCEMENTS FOOD PRICE INCREASES TO DATE, ARE THEY BEING RAISED SECRETLY? WHAT ITEMS AFFECTED? BREAD PRICES BEING INCREASED? HOW MUCH AS MUCH AS THIRTY PERCENT PINE MEAT PRICES LAST YEAR? **NOTIFICATION WHEN MEAT AND MILK PRICES INCREASED**

3. KHRUSHCHEV IN PLENUM SPEECH SAID GRAIN CROP TWENTY PERCENT BELOW LAST YEAR NOT MEAT SUPPLIES UP. AS LATTER RESULT EXTENSIVE BUSINESS SLAUGHTERING LIVESTOCK IN VIEW SEVERE FODDER SHORTAGE KHRUSHCHEV ALSO SAID MILK PRODUCTION DOWN THIS YEAR. DOES THIS INCREASE MEAT MILK CANS BEING SLAUGHTERED DUE FODDER SHORTAGE?

4. IF FODDER IN SUCH SHORT SUPPLY WIDESPREAD SLAUGHTERING NECESSARY, WILL SOVIET GOVERNMENT FOLLOW HUNGARY EXAMPLE AND BUY FEED GRAINS ABROAD, IN ADDITION WHAT FOR HUMAN CONSUMPTION?

5. KHRUSHCHEV SAID SOVIET COMRADES STARVED 19-7 WHILE GRAIN BEING EXPORTED, PRIMARILY TO BUY FOR DEFENSE MACHINERY AND OTHER CAPITAL GOODS. COULD SITUATION BECOME THAT SERIOUS THIS YEAR? WILL THE SOVIET BE OBLIGED CONTINUE FOOD SHIPMENTS CUBA IN EXCHANGE REGARDLESS  
OF THE STATE OF CUBA? WILL THESE SHIPMENTS CONTINUE OR WILL GOODS BE RETURNED  
FOR NEW AGRICULTURAL EFFORT?

THE NEW CHEMICAL PROGRAM WILL BE TREMENDOUS DRAIN ON SOVIET ECONOMY.  
WILL THE INVESTMENT IN CHEMICALS BE FINANCED BY REDUCING SOVIET MILITARY POWER OR SACRIFICING  
ECONOMIC GROWTH. THEREFORE WILL NOT CONSUMPTION SECTOR BEAR BURDEN THIS INVEST-  
MENT? WILL INVESTMENT PROGRAM (FERTILIZER, PESTICIDES, HERBICIDES) LARGELY  
IMPROVE FOOD AND FIBER PRODUCTION, AND AMOUNTS EXPANDED OF INCREASING FOOD AND  
CLOTHING PRODUCTION THROUGH CHEMICAL PROGRAM, WILL NOT MOST OF WHICH INVESTMENT  
FALL ON HOUSING, ONLY LITTLE CONSUMPTION SECTOR REMAINING. WILL NOT HOUSING  
CONSTRUCTION BE CUT SHARPLY OR ALMOST HALTED? BESIDES WILL NOT HOUSING PROBLEM  
BE INTENSIFIED BY DEFILIX WORKERS TO MAN NEW CHEMICAL FACTORIES, MANY OF WHICH  
IN AREAS WHERE LITTLE HOUSING NOW AVAILABLE?

8. IS KHRUSHCHEV DEMAND FOR CREDIT FROM WEST TO FINANCE INVESTMENT PROGRAM

10. IF USSR RECEIVES LONG TERM CREDITS FROM WEST FOR CHEMICAL PROGRAM AND  
OTHERS. WHAT MEASURES BE TAKEN PAY BACK LOANS? WILL INTERESTS BE SOUGHT,  
OR IS SOME OTHER SOLUTION AT HAND?

11. PRIVATE PLOTS OF FARM WORKERS MOST PRODUCTIVE THAN SOVIET AGRICULTURE,  
AND ADDITIONAL INCREASES WOULD RESULT LARGER GAIN FOOD OUTPUT. WILL  
ANY MEASURES BE TAKEN TO HOLD PEASANTS FOR USE OF PLOTS?

12. SOVIET GOVERNMENT MUST REALIZE FROM REP PERIOD AND RUSSIAN MOBILIZATION,  
FROM EXAMPLE OF PEASANT PRIVATE PLOTS SINCE 1930s THAT GIVING LAND TO PEASANTS  
WOULD BE MOST EFFECTIVE WAY TO INCREASE FOOD FOR SOVIET POPULATION. POLITICAL  
DISAFFECTION IS NOT ANOTHER REASON THIS NOT BEING DONE YEAR OF  
RUSSIAN INTERWAR PERIOD SUCH AS DISRUPTED REP PERIOD, THAT INFLATION WOULD  
RESULT FROM OVERPRODUCTION ON FARMS, FOR WHICH NO CONSUMER GOODS TO EXCHANGE. IS  
NOT SEPARATE ADMINISTRATION AND INCH PEASANTRY ONE MAY HOLD DOWN DEMAND FOR CONSUMERS  
GOODS, WHICH WOULD IN VERY SHORT ORDER, AND TO CONCENTRATE ON MILITARY AND  
INTERNAL PRODUCTION WITHOUT EXCESSIVE INFLATIONARY PRESSURE REGARDLESS  
WHAT THE CONSEQUENCES, WOULD SOVIET GOVERNMENT REALLY WANT PROGRESSIVE PEASANTRY,  
AND TO AVOID MILITARY POWER, FOREIGN ACQUISITIONS, ECONOMIC GROWTH

CONVINCE ANY BELIEVE THEIR WAGES TOO LOW AND MUST BE INCREASED?  
14. PHYSICAL THROUGH LATEST IN LONG SERIES PARADES, INCLUDING NEW LANDS,
