SUBJECT Anastasio de la GARZA aka Randel E. Fitzpatrick

ACTION REQUIRED - REFERENCES

Reference: **BMW-1112**

1. On 23 May 1962 Anastasio de la Garza telephoned the <sup>32</sup>ODACID installation and requested an interview with the ODENVY representative. He was told at that time that no ODENVY representative was located in Monterrey but was given the name of an officer in <sup>32</sup>(ODACID) (actually the ODENVY representative) with whom he might discuss his problem. Subject said that he was mainly interested in obtaining employment with KUBARK. At the time of this conversation, the Subject said that he was Mexican born and was now a naturalized U.S. citizen using the name Randel E. Fitzpatrick. The ODENVY representative suggested that Subject should send a letter to KUBARK Headquarters since no one in Monterrey could help him.

2. On 7 September 1962 Subject again telephoned the <sup>32</sup>(ODACID) installation and asked to speak with the same ODENVY representative. His story was the same as reported in paragraph one above. The ODENVY representative gave him the address of KUBARK Headquarters.

3. On 12 July 1963 Subject came personally to the <sup>32</sup>(ODACID) installation and asked the local receptionist if he could talk with the KUBARK installation. GARDYNE was at the reception desk at the time and the receptionist asked GARDYNE if he knew anyone that Subject could contact. GARDYNE <sup>32</sup>(as an ODACID official) spoke with Subject who said that he wanted to obtain employment with KUBARK. GARDYNE suggested that Subject write directly to KUBARK Headquarters and send them his biographic data and reasons for seeking employment. Subject wanted to know at that time if <sup>32</sup>(ODACID) would forward his letter since he didn't trust the Mexican mail system completely. GARDYNE suggested that in that case it might be better to post the letter in the U.S. Subject gave GARDYNE a personal calling card at that time identifying himself as the assistant manager for "valores" at the Banco de Fomento Hipotecario, S.A. located in Monterrey.

4. Subject speaks excellent English, is about 5'8 1/2" in height, weighs about 155 pounds, and is slightly bald.

5. A complete name trace of <sup>32</sup>(ODACID) ODENVY and Base files reveals no additional information on Subject at this time. A check of the Polietileno

In view of the apparent fact that Subject probably had made known his interest in KUBARK employment to some of his friends, and considering the fact that he had not suggested any actual access to targets of KUBARK interest, the Base decided not to take any action in this case when it first came to the attention of Base personnel. The Base will furnish Headquarters with any additional information which might be developed on Subject in the future.
