- Hal Tittsler, ASAC, MFO called to request a name check on Hemming and a Ron Mongul or Mongel.
- Tittsler was advised that OS had no record of Mongul or Mongel, but that a file existed on Hemming.
- Tittsler explained that the Miami DCD Office was queried by the Dade County Organized Crime Division as to whether or not Hemming ever worked for the CIA in Mexico. The same inquiry pertained to Mongel or Mongul.
- 4. I told Hal that Hemming never worked for the CIA, and that he has falsely claimed to have worked for the CIA on several occasions. I also said that I thought this should be the limit of his response other than to refer the Organized Crime Division to the United States Attorney's Office in Miami for further information concerning Hemming, as he was to have been brought to trial there in August 1977.

5. I also advised Hal that inquiries of this nature should be formalized.
