HE WAREND INTERVIEWING CONSUL THAT UNLESS PROMISES MADE TO HIM BY US OFFICIALS WERE HONORED HE WOULD REVEAL TO THE PRESS ENTIRE STORY OF HIS ALLEGED CONTACTS WITH WOFIRM AND WOULD EXPOSE INDIVIDUALS WITH WHOM HE HAD DEALT IN THE ORGANIZATION.

2. UNLESS ADVISED TO CONTRARY ¹⁵⁻¹⁸ WILL, AS IT HAS IN THE PAST, LEAVE THIS MATTER STRICTLY TO CONSULATE. ¹⁵⁻¹⁰ PLEASE ADVISE LNER-GO.
