Subj has now been relieved of his Presidency of FEU, allegedly because of boose and women, but probably because he didn't play ball with the PSP re Univ politics. Subj is considered by friends to be anti-Communist and also rather critical of the USA. First contact with Subj by a KUBARKER was during a meeting in Mexico City on 9 March 1961. This meeting was arranged by Subj good friend, Carlos TEPEDINO, Cuban dissident now in jewelry business in NYC. 04 also a good long@time acquaintence The staffer was W. of TEPEDINO s. The meeting was merely "to exchange views on Cube", understood this.
