2. AGREE ALL MEMBERS AMCIQAR SHOULD BE STICKING TO KNITTING. HOWEVER ALSO RECOGNIZE IMPORTANCE PRINCIPLE MENTIONED PARA ONE REF A AND BELIEVE THAT AMHANK HAVING APPLIED SHOULD NOT BACK AWAY AND HE SHOULD TRY MAKE THIS STICK.

3. FYI GENL. FYI PARA FOUR REF A NO COMMITMENTS AS TO POSITIONS THEY WILL HOLD IN FUTURE HAVE BEEN MADE TO AMHANK OR ANY OTHER MEMBER AMCIQAR.
