- 1. The following is a statement which Mr. Budy Gomez and Mr. Bob Dahlgren of WH Division have suthorised CI Staff to pass to Mr. Sam Papich of the FBI:
 - A. Harcos Diaz Lans, brother of Jungio Diaz Lans, departed Cuba with the assistance of CLA and is now in Tamps where he arrived on 27 July with the assistance of INS. Subject is now under the control of our representatives in Tampa and will depart for Missi on 29 or 30 July where he will be available to the FBI for debriefing.
 - B. Subject is being handled in this way to avoid all publicity until his wife and children, who are still in Cuba, are able to leave that country.
 - C. Becsuse of the sensitivity of this matter, it is requested that this information not be disseminated outside your Bureau.
