1. FOR HAVA FBI ONLY: RAFAEL RAY IN CONVERSATION WITH HENRI PADILLA HIS ASSET. DESCRIBED PADILLA'S POSITION AS CITED REF. RAY HAD PLANNED THE DEFECTION OF ONE SIDE OF PINES GARRISON TO COLUMBIA LIBERATION BRIGADES. WITH BRIGADES FREE AND REMAINING IN CURA AND GARRISON ON ASPI CASERO SIDE RAY THOUGHT IDEAL OF PINES COULD BECOME SIGNIFICANT BASE FOR MIL OPS. DESCRIBED IDEAL OF PINES AS IDEAL WOULD BECOME ONE OF OUR BRIGADES. FOR NUMBER REASONS WHICH PRIMARILY POLITICAL AND TO BE REPORTED BY SEPARATE MESSAGE, OUR RELATIONS WITH RAY GROUP STRAINED. ALSO REF PLANNING FOR ABOVE OF BRILL EXHIBITS AND IT BECOMES CLEARER EVERY DAY THAT RAY CLAIMS SPECIFIC ASSETS LOCAL ONLY TO HIM WHILE HE HAS REF. REF APPEARS CASE IN POINT.

2. FOR HASE: TO FREE HENRI BRIGADES VIA AIRCRAFT (AGRAF) AND ATTEMPT STEER BRIGADES INTO AIRCRAFT CAMP OF COURSE OF MUCH SIGNIFICANCE TO HAVANA OBJECTIVES GENERALLY AND AIRCRAFT PREPARE SPECIFICALLY. YES, STRONGLY BELIEVE WE SHOULD PUT BEST FOOT FORWARD AND EXPLORE MATTER IF REPORTS REF AND PARA (1) ABOVE SUBSTANTIATED. SUBJECT TO HAVA COMMENTS SUBJECT AIRCRAFT BE CONTACTED AT CELE THIS REGARD AND BE ASKED HIS HAVA REF ASCERTAIN ALL NECESSARY DETAILS.
