ON 15 AUGUST 1962 ANTONIO VARONA LOREDO, DEPUTY CHIEF OF THE CUBAN REVOLUTIONARY COUNCIL (CRC), VISITED PRESIDENT ROBERTO CHIARI OF F NAMA AND REQUESTED CHIARI TO ORGANIZE AND HOST A MEET-ING OF CENTRAL AMERICAN CHIEFS OF STATE ON THE CUBAN ISSUE WITH EMPHASIS ON INFILTRATION OF CASTRO AGENTS INTO CENTRAL AMERICA. VARONA SAID THAT SUCH A MEETING SHOULD BE HELD AT A VERY EARLY DATE AND THAT CHIARI SHOULD INVITE PRESIDENT KENNEDY TO ATTEND. CHIARI TOLD VARONA THAT THIS WOULD BE A WOST SERIOUS UNDERTAKING REQUIRING INTENSIVE STUDY AND THAT HE COULD MAKE NO COMMITMENT TO VARONA ON THE MATTER. ON 16 AUGUST VARONA LEFT PANAMA FOR SAN JOSE, COSTA RICA, SAYING HE WOULD RETURN TO PANAMA ON

- 2. ON 20 AUGUST A GROUP OF CUBAN EXILES IN PANAMA CALLED ON MARCOS ROBLES, PANAMANIAN MINISTER OF GOVERNMENT AND JUSTICE. AND REQUESTED ROBLES TO TRY TO PERSUADE PRESIDENT CHIARI TO PERMIT THE ESTABLISHMENT IN PANAMA OF A TRAINING BASE FOR CUBAN EXILES.
