2. FYI AFTER SEVERAL DRINKS IN AIRPORT LOUNGE HOFFMAN TOLD ANSWIRL/1 HE IS SECRET AGENT FOR CANADIAN GOVT, THOUGH OTHER MEN IN HIS "CORPORATION" NOT AWARE OF THIS. STATED HE EXPECTS RETURN VIA KEY WEST APPROX 25 APRIL WHEN HE HOPED HAVE SOMETHING IMPORTANT FOR HIS ORGANIZATION.
