1. G-2 reported that an 7 May 1950 a B-26 type bonter arrived in David, Panama, from Brownerville, Texas, due to a low gonoline supply. The plane was headed for Tocumen Airport in Panama City, and carried as a crew the following according to G-2:

Frank O'GFL, U.S. Citizen, Pilot O. MARTINEZ, U.S. Citizen, Co-Pilot Steve EUREAY, U.S. Citizen, Kachanic Mauricio Castro, Fantmanian, Passenger

(A tire blew out at Lavid, and Civil Aeronautics technician at Tocumen Airport was instrumental in getting a spare tire to them,

It is piloted by Steve MURRAY, and at least two other americans ride on the plane, which is we sometimes met at Tocumen Airport by either Tito, Harmodito or Toni ARIAS. On landing at the airport it goes directly to a hangar, and allegedly the only ones who visit it are the ARIAS brothers, PASTOR Ponce, Chief of the Airport, and one (fnu) LIMARES, Chief of Customs at Tocumen.

Finformant stated that it was bolieved at first that the plane was engaged in arms contraband, but later it appeared more logical to assume that it was involved in another type of smuggling, possibly drugs.

He stated that he was in the export-import business and that he dealt in gold. He said that he had come to Fanara to see a man by the mane of SaS, a gold dealer from Buenos Aires, about gold shipments.

the U.S. Ambassador stating that prior to arriving in immary the matter to been signaled, that all was not well at the airport and that, the crew had jettisomed corgo prior to arrival. (A check with the Air Force authorities does not confirm that any such message was sent and NUCLLY denies that any thing was jettisomed. He insisted that he was coming to Panama to discuss the gold business but that he had no cargo.) The Minister also advised the Ambassador that PASTOR Ponce had been fired as Read of the airport.

7. In a conversation with PASTER Ponce and FURRAY on the night of 8 July was advised that PASTER Ponce had, in fact, been fired and that he was determined to bump off Toni ARIAS. Both FURRAY and PASTER Fonce claimed that Toni ARIAS was behind it all but that PASTER Ponce was the fall toy.

6. The Mexican/referred to Acristohal Marina, and the Mexican Zorhio, are believed to be identical. Sas has toen identified as Formarderis, a gold dealer, who operates in Busines Aircs and Montevideo. Civil Intelligence Settion has advised that Sas was staying with Toni Ariss and that has departed from Panama hautily. Ciscalso-advised that President Ariss at first-had given orders for the/dismissal of both his neshew, Toni Ariss, and Paster Ponce, but it was later agreed that Toni Ariss would not be fired to avoid a public scandle of the President's family.

9. The present status of the matter is that the plane has been searched with negative results, that the plane is still being held by the Panamanian authorities and that MUMRAY and ethers are endeavoring by every means possible to secure the release of the plane. The head of the Documen Airport, PASTOR Ponce, has been dismissed and Toni ARIAS, the President's regrew, will probably be allowed to withdraw from his position gracefully.
