Transmitted under separate cover in duplicate are copies of four photographs found by CINCH and CDCFAL investigators among the joint personal effects left behind by Berne Ferguson *MITCHELL (201-282337) and William hamilton *MARTIN (201-282338) at the time of their departure from the United States in June 1 68 enroute to Mexico City and thence to the USSR. These photographs have been provided to KUBABA for our internal use only, except for permission to show them to EGGIANI for their possible identification of the individuals depicted thereon. O1</p> <p>2. The circumstances under which the photographs were found precluded the establishment of whether they were the possessions of or taken by MARTIN or MITCHELL, although the backgrounds and the individuals appearing in the photographs converge in some cases, are similar in some, are presumably at some unknown date between 1-51 and mid-1-55.</p> <p>3. Attention is invited particularly to Photograph A, depicting an unidentified elderly Caucasian male, who is thought possibly to be identical either with George *PERISTERICOPULOS aka PERIS (201-284530), known to have been a contact of MARTIN's, or with Mortimer Claggett *COOK, Sr., recently deceased Tokyo Representative of the American Red Cross. For convenience in future reference in event of identification of any of these individuals, the pictures have been labeled A through D. The other individuals appearing on photographs B, C and D are completely unknown.</p> <p>12-3</p> <p>4. It is requested that [] attempt to establish the identities of these individuals, first by circulating among station personnel the photographs minus background data or other indication of the connection of these persons</p>
