1. CLERK POLICE CONTACT ADVISED CLIFFORD V. CORNELL, AGE 38; HAROLD WHIDDLE, AGE 45; RENE ERIC BLOM, AGE 36, ARRESTED WAVE AREA FOR THREY 40 CASES DYNAMITE AND ILLEGAL POSSESSION EXPLOSIVES. CORNELL APPEARED JUSTICE PEACE COURT AND CLAIMED STOLE DYNAMITE FROM JOSEPH N. NEROLA, SUBARK AGENT. CORNELL'S TRIAL DATE NOT SET BUT PLANS WAVE DEFENSE BE POWED FOR KUBARKER.
