1. HQS CONSIDERS IN ADVANTAGE LOCATING [redacted] IN ESCAMBAY PROVIDED CAN BE ASSURED HE WORK COMPATIBLY WITH ATLANTIC-5 AND OTHERS IN CONSOLIDATING DIVERSE POLITICAL/MILITARY UNITS UNDER AMRASP LABEL. IF HAVA CONSIDERS THIS REALISTIC AND [FIALLO] WILLING ACCEPT SUPPORT REQUESTED FOR FAMILY AUTHORIZED.
2. PREFER HOWEVER THAT SUPPORT [FIALLO] FAMILY COME FROM AMRASP THRU GOOD OFFICES AMPALM FIVE. SUCH ARRANGEMENT WILL ESTABLISH ELEMENT AMRASP CONTROL OF KEY INDIVIDUAL MANOLO RAY GROUP.
3. SUGGEST HAVA MASH MAKE KNOWN AMPALM FIVE [FIALLO] INTENTIONS AND FINANCIAL NEEDS AND ARRANGE AMRASP COMMITMENT SUPPORT. AFTER WHICH MESSAGE TRANSMITTED AMPALM FIVE TO [FIALLO] THIS EFFORT. IN ANY EVENT MASH EXCLUDE AMPALM ONE THIS MATTER IF POSSIBLE.
4. FOR MASH: IF HAVA CONCURS PARA 3 PLS IMPLEMENT.
