- ODENVY REPORT FROM FRANCISCO BESTARD FORMER G 2 AGENT REVEALED THAT EX-CAPTAIN RODRIGUEZ TAMAYO AKA EL MEJICANO AND FOUR COLLEAGUES WHO WORKING WITH DIAZ LANZ GROUP VOLUNTEERED PROVIDE CUBAN G 2 FOLLOWING INFO:
 - WHO FINANCING DIAZ LANZ GROUP IN CUBA.
 - LOCATION OF ARMS IN CUBA.
 - NAMES OF DIAZ LANZ GROUP MEMBERS IN CUBA.
 - LOCATIONS OUTSIDE CUBA WHERE WAR MATERIALS STORED.
 - PLACE DATE TIMES OF PLANE DEPARTURES FOR CUBA.
 - GENERAL PLANS OF THE COUNTER REVOLUTION.
- TAMAYO STATED THAT EACH REPORT FURNISHED WOULD PROVIDE SUFFICIENT PROOF PUT SUBVS THEREOF IN PRISON. OFFERED FOR 7,500 DOLLARS DOWN AND 2,500 DOLLARS AT TIME INFO VERIFIED TO REVEAL PERSON INSIDE CUBA FINANCING COUNTER REVOLUTION STATING 33 MILLION PESOS CAN BE SEIZED FROM THIS PERSON.
- TAMAYO ALSO STATED ONLY [Redacted] REMAINING US IS THAT SHORT WHILE AGO HE SENTENCED 30 YEARS PRISON CUBA.
