SUBJECT: ANTI-CASTRO ACTIVITIES

- 1. ON 13 AUGUST 1962 A FAIRLY RELIABLE SOURCE REPORTED HE HAD BEEN CONTACTED BY ALEXANDER I. RORKE WHO INDICATED HE (RORKE) AND HE FRIENDS, FRANK ANTHONY STURGES AND OSCAR ALESTINE MASCARO, "WERE ALL SET TO DO SOMETHING"; THEY HAD AN AIRCRAFF OF UNDISCLOSED TYPE, AND NEEDED A BOAT. SOURCE SAID ROPKE SERMED TO BE BRARCHING FOR INDICATIONS AS TO WHETHER SOURCE WOULD GIVE ANY MORETARY SUPPORT TO HIS ACTIVITIES.
- 2. ON 18 AUGUST 1962, RORKE SHOWED SOURCE A PICTURE OF A GRUMAN BEARCAT AIRCRAFT ALLEGEDLY OWNED BY AN UNIDENTIFIED (BY RORKE) ANTI-CASTRO CUBAN EXILE STUDENT GROUP WITH WHICH RORKE CLAIMED TO BE ASSOCIATED. RORKE STATED THE STUDENT GROUP WAS ATTEMPTING TO BUY A BOAT AND WAS THINKING OF SOMEONG (CONTINUED)

- 8. ON 31 AUGUST 1962 BORKE TOLD SOURCE HE HAD SOLUTION I TO DO WITH THE RECENT RAID AND SHELLING OF HADANA BY THE DERECTORIO REVOLUCIONARIO ESTUDIANTIL (DICE) CARRAMLATION, AND THEY WERE COING TO TAKE ACTION AGAIN JOON. IRRIGIE ONCE ARRAMMENTED FOR AN INDICATION AS TO WHETHER SOURCE ACCULT LIVE ALLY MONETARY SUPPORT TO HIS ACTIVITIES.
- 4. ON 8 SEPTEMBER 1962 FORKE TOLD SOURCE HE HAD THREE HOAT INCLUDING CUBAN AND AMERICAN CREWS AND AN AIRCRAFT READY FOR RAIDS AGAINST CUBA. HORKE SAID BE WAS IN GREAT NEED OF ABOAT TWENTY TWO THOULAND DOLLARS TO BUT GUNS AND AMERICANTION AND THAT A RAID WAS BEING PLANNED FOR NEXT WEEL. TARCET, FOR THE RAID ARE A PETEGLEUM REFINERY AND NAVIGATIONAL AID. ON THE NORTH COAST OF CUBA.
- 5. ON 8 SEPTEMBER 1962 SOURCE SAID HE HAD RECENTLY MET A REPRESENTATIVE OF THE AMERICAN (CONTINUE)...

SOURCE SAID BORKE WAS ATTEMPTING TO GET ASSISTANCE FROM THE CENTRAL INTELLIGENCE AGENCY, OR AT LEAST THE SUPPORT OF THE AGENCY, TO PREVENT INTERFERENCE FROM OTHER UNITED STATES GOVERNMENT ELEMENTS IN HIS ANTI-CASTRO CPERATIONS.
