VECIANA LEAVING U.S. 3 AUGUST FOR BOLIVIA WHERE HE WILL SERVE WITH AID. VECIANA GAVE NO EXPLANATION FOR HIS OPINIONS ON RUIZ TO CUBAN AFFAIRS OFFICE WHO TOLD HIM TO REPORT DETAILS TO EMBASSY LA PAZ UPON ARRIVAL.

TO CUBAN AFFAIRS OFFICE. AT THAT TIME IT WAS ASCERTAINED THAT NONE OF VECIANA FAMILY WERE IN TOUCH WITH RUIZ WIFE. ALSO VECIANA NOW AWARE RUIZ STATIONED MADRID BUT APPARENTLY UNAWARE RUIZ POSITION AS RANKING CUBAN DIPLOMAT THERE.
