use KUBARK funds to promote his personal interests and, consequently, he was terminated in Uctober of 1959.

- 6. With regard to Subject's assertions as reported in reference, we wish to comment that:
- a. Although we cannot confirm or controvert his status as vice-president of FINA, in April of 1963 he allowed to ODENVY at Atlanta that he was president of Communications International, Inc. ODENVY had contacted Subject to determine his possible connection with Dr. Elmer Henry LOUGILIA, who has recently been indicted as an unregistered agent of the daitian Government.
- b. While his claim of past KUTWIN service is true, the degree of his friendship with that service's well-known director remains open to speculation, for there are no indications that the two were even acquainted.
- 7. Further to the above, in October of 1962 Subject was being investigated by ODENYY for his possible involvement in 1959 in the shipping of arms to Ecuador.
- 8. The above salient features as to Subject's background, should be sufficient to discourage any operational use of subject, and to indicate the need for caution on AtTIGER'S part should he have any further contact with him. At the same time, deadquarters considers that information on Subject' local activities and contacts, as could affect ODYOKE interests, should be reported as such becomes known to the Station.
