1. SUBJ REF & NOW AMHIP ONE MET AS PLANNED. HE FAIRLY CERTAIN AMHIP ONE (IDEN) WILL DEFECT AND AGREE TO KNOWLEDGE EXPLOITATION PER REFS.

2. ACCORDING AMHIP SUBJ INTERESTED CONSTRUCTIVE EMPLOYMENT AGAINST CASTRO REGIME AFTER DEFECTION RATHER THAN VAGUE IN MIAMI. PROBABLY NOT INTERESTED AFFILIATING WITH PRESENT EXILE CUBAN GROUPS AND POLITICIANS. ADVISE WHETHER WAVE INTERESTED USING AMHIP IN KNOWLEDGE OR OTHER LONG TERM SIMILAR ASSIGNMENT. IN LIGHT CLOSE AFFILIATION CASTRO REGIME PERSONALITIES, CAN WAVE BE MOST APPROPRIATE USE? ~~AMHIP ONE INTERESTED CONSTRUCTIVE EMPLOYMENT AGAINST CASTRO REGIME AFTER DEFECTION RATHER THAN VAGUE IN MIAMI. PROBABLY NOT INTERESTED AFFILIATING WITH PRESENT EXILE CUBAN GROUPS AND POLITICIANS. ADVISE WHETHER WAVE INTERESTED USING AMHIP IN KNOWLEDGE OR OTHER LONG TERM SIMILAR ASSIGNMENT.
