FIELD REPORT NO.

1. ANTONIO CARRILLO CARRERAS, CUBAN AMBASSADOR TO FRANCE, IS INTERESTED IN PURSUING POSSIBILITIES FOR IMPROVING CUBAN-U.S. RELATIONS. HE HAS REMARKED PRIVATELY THAT ONE OF THE CONCESSIONS WHICH CUBA COULD CONSIDER TO IMPROVE RELATIONS INVOLVES THE GUARANTEED PURCHASE BY THE U.S. OF ONE MILLION TONS OF CUBAN SUGAR ANNUALLY. UNDER THOSE CIRCUMSTANCES CUBA WOULD BE PREPARED TO APPLY APPROXIMATELY 20 PER CENT OF THE PROCEEDS TO INDEMNIFY U.S. COMPANIES WHOSE PROPERTY HAS BEEN EXPROPRIATED BY THE CUBAN GOVERNMENT. SIMILARLY, PAN AMERICAN FLIGHTS TO CUBA, WHICH CARRILLO CLAIMS WERE NOT ENDED BY CUBA, COULD BE RESUMED. MEANWHILE, SABOTAGE EFFORTS BY THE U.S., SUCH AS THOSE DIRECTED
