1. 1 OCT ⁰²UNSNAFU 19 SHOWED AMWHIP ONE STOCKWOOD CARD AND IDENTIFIED HIM AS KUBARKER WITH WHOM MAD HAD HAD CONTACT FOR UNSPECIFIED PURPOSE. SAID HE GOING CALL STOCKWOOD SOON TO COMPLAIN ABOUT KUBARK ATTEMPT RECRUIT ONE OF ⁰²UNSNAFU 19 EMPLOYEES FOR 622 DOLLARS MONTH.

2. NO ATTEMPT INVOLVING THIS SUM MADE RECENTLY BY ¹⁵⁻⁴[PARI]. CLOSEST TO IT WAS STOCKWOOD MEET 25 SEP WITH ⁰²UNSNAFU 22. STOCKWOOD THEN SAID TO U 22 WHO MAKING NOISES ABOUT QUITTING JOB WITH ⁰²UNSNAFU 7 THAT STOCKWOOD WOULD BE INTERESTED HIS STAYING ON AND WOULD BE PREPARED HELP MEET HIS MATERIAL NEEDS. ⁰²[U]22 GOT POINT. SAID WOULD NOT TAKE MONEY AND WOULD NOT KNOWINGLY REVEAL INFO WHICH HIS EMPLOYERS CONSIDERED CLASSIFIED BUT HAPPY CONTINUE MEET STOCKWOOD ANY TIME LATTER DESIRED. STRESSED NORMALLY HAD NO ACCESS CLASSIFIED INFO. CONCEIVABLE BUT NOT PROBABLE ⁰²[U]23 TALKED OF MEET.

3. IF MCS OR MADR KNOWS OF ANY SUCH RECENT PITCH PLS ADVISE DETAILS. WHILE STOCKWOOD COULD USE CALL FROM ⁰²[U]19 AS EXCUSE BUT HEN, ASSUME DIR 21754 WOULD STILL APPLYING. IF NOT PLS GIVE PERMISSION EXPLOIT THIS OPENING IF IT DEVELOPS.
