KAPOK KEYWAY PBIUNEN MIFREZE AMWHIP

1. HQS PLANNING CONTACT ASSESS VARIOUS MEMBERS CUBAN DELEGATION UNITED NATIONS CONFERENCE ON TRADE AND DEVELOPMENT (UNCTAD). PRESENTLY HAVE LEADS TO SEVERAL, HOWEVER UPDATED EVALUATIONS TRUE POLITICAL SYMPATHIES AND/OR RECRUITMENT SUSCEPTIBILITIES OF MAJORITY ARE LACKING.
2. WOULD LIKE USE AMWHIP/2 TO MINGLE WITH DELEGATES AS "APOLITICAL" BUSINESSMAN TO SPOT AND ASSESS. WOULD NOT USE FOR PITCHES OR COMPROMISING ACTIVITIES. IF FEASIBLE MIGHT ALSO LIKE INFREQUENT USE HIS APARTMENT. FORESEE NO NEED USE A/2 FOR LONG CONTINUOUS PERIODS, RATHER ONLY FOR INITIAL SCOUTING AND THEREAFTER FOR ASSIGNMENTS AGAINST INDIVIDUALS AS NEEDS AROSE. SINCE UNCTAD LASTS THRU 15 JUNE, COULD PERHAPS ARRANGE SHARE A/2 BETWEEN ROME GNEVA. WILL ROME PLS DETERMINE A/2'S CAPABILITY PURSUE ABOVE ROLE AND HIS WILLINGNESS MEET "BEN DAMER" GNEVA FOR DETAILED OPS BRIEFING. IF WEEK 12 APRIL NOT FLASIBLE, THEN SOONEST THEREAFTER DESIRABLE.

1. HAS BEEN A/2 CONFIDENTIAL DATA, HAVE RECEIVED HIS PDA UNTIL 15 JUNE. IF HE TO BE USED SOME AFTER THAT DATE, PLS FORWARD HIM PART IN FOR US.

2. THE COM. BE COMA 6452 (IN 5048), A/2 NORMALLY RESIDENT COMA, SEE COMA 10106, 10 DEC. 63. ALSO ASSIST/1 BCE EUROPE CIRCA WHEN 20 APRIL ON BUSINESS TRIP. FIRST STIP PARTS ON BEHALF KURAK AND WAITING TO COMA FOR TEN DAYS. THEREFORE, IF POSSIBLE REQUEST RAPIDLY INFORM HUS BY 17 APRIL IF AND WHEN A/2'S SERVICES NEEDED. INCLUDE CONTACT INSTRUCTIONS.

3. AS ADDRESS KNOW, AMBIEP 1 AND 2 ARE OLD FRIENDS BUSINESS PARTNERS, THIS RELATIONSHIP COMPLICATION DIFFICULT. IN FACT, GIVEN COMA NEUTRALITY AND REPORTS FROM SOME OF SUBJECT, IT NOT THE BELIEFING THINK BOTH AREN'T WELL AWARE THE OTHER IS COOPERATING WITH RUSSIA. ALTHOUGH OPS DETAILS ARE USUALLY NOT DISCUSSED. THUS, HAS MORE TO BELIEVES AND HAS NO OBJECTIONS IF COMA FEELS, THEY HANDED DOWN AS USUAL. HOWEVER, SINCE COMA HAS PRINCIPAL LONG-RANGE INTEREST IN A/2 FOR ITALIAN OPERATIONS, DEFER TO COMA WISHES ON THIS POINT.
