<p>1. At a 20 August 1966 meeting ANSHIP/2 was asked about a series of PERUMAS (11 in all) who, he was told, are or have been in Rome. Included in the list at intervals were ANASH/1, 2, and 3. (SOURCE comment: In accordance with a discussion with LANGOSCH during his recent trip to Rome.) ANSHIP/2 was given no further information and nothing about the fifteen men except their names.</p> <p>a. Subject did not respond re ANASH/3.</p> <p>b. Subject had heard ANSHIP/1 and others mention ANASH/2, whom Subject does not know personally. He knew of him only that he had been in Paris a number of times and that he was said to be stupid.</p> <p>c. Subject knows ANASH/1 well, although not as well as does ANSHIP/1, through whom ANSHIP/2 met ANASH/1. Subject described ANASH/1 as a very complicated person of confusing and perhaps confused loyalties. Once, when ANASH/1 was so drunk and ill that he was heading for the bathroom to vomit, he kept shouting curses at the ANTRUC regime which "murdered my son." Sober, he is also critical of ANTRUC. But as soon as anyone else is similarly critical, ANASH/1 immediately defends ANTRUC and his government. ANSHIP/2 believes that ANASH/1 is emotionally and psychologically mixed up and does not know where he stands.</p> <p>d. ANSHIP/2 knows why ANSHIP/1 and ANASH/1 met. (He did not state the reason and was not asked.) He knew, however, only through what ANSHIP/1 volunteered, and not through being present at any meetings. When these occurred, if ANSHIP/2 chanced to be present, he left the room voluntarily and at the outset.</p>

2. Regarding Ambassador Antonio CARRILLO (arrived (201-349956) AMNHIP/2 feels sure that he is not presently acceptable and is clearly pro-regime. (On the other hand, he is not happy in his job, complaining that he was not cut out to work constantly and under pressure, and would prefer a quieter post in western Europe. With some help from Subject, arranging bookings, CARRILLO has gone to Benicorm, Spain, for most or all of the month of August. (At least Subject thinks that he is there.) AMNHIP/2 was instructed to let us know whenever he is privy to the vacation plans of CARRILLO, or anyone else similarly placed, well enough in Havana and with the secret proviso that he was not himself involved in the arrangements (Comment: So that, if a pitch seems reasonable, there will not be a danger of blow-back). As was reported earlier, it has been many months since CARRILLO has offered Subject any jewelry, and those transactions may have come to a close. CARRILLO did make a recent attempt to sell a painting to AMNHIP/2.

3. A Cuban person, AMNHIP/2 has made repeated, discreet inquiries, alleging that he wants to send money to his wife's mother, who is dying of cancer. He states that it is impossible to get them. If it could be done, he says, [redacted] of (GIRA)40385, 20 May 1965) could do it. And he can't. 06

4. AMNHIP/2 continues to express grave concern about AMNHIP/1's sexual relationship with ILEN A of (GIRA)38996, 16 December 1964. Subject says that A/1 is so infatuated that he now wants a divorce in order to marry ILEN. A/2 repeats that ILEN is a woman of loose morals who was notorious as such even before she left Cuba. He stresses that A/1 tells her everything: "Alles, Alles, Alles!"

5. Finally, Subject said that information about A/1 which he had previously passed to BUNCK (odily, he flatly refused to specify what information, although it is probable that it is the information about ILEN A) had been leaked back somehow to AMNHIP/1 several months ago. As a result, A/1 could have been put in a position to surmise that A/2 has a relationship with KUBARK, a fact which A/2 makes every effort to conceal from A/1 and everyone else, including A/2's wife. A/2 says that he has managed to divert any A/1 suspicions and smooth any ruffled feathers. However, because A/1 is his friend and business partner, and because A/2 is keenly aware of the importance of security, he asked that BUNCK guarantee that there will be no further leaks, that BUNCK accept A/2 info in confidence, or that BUNCK recognize that A/2, lacking such guarantees, cannot furnish any more information which might get him into trouble. Headquarters comments are requested.
