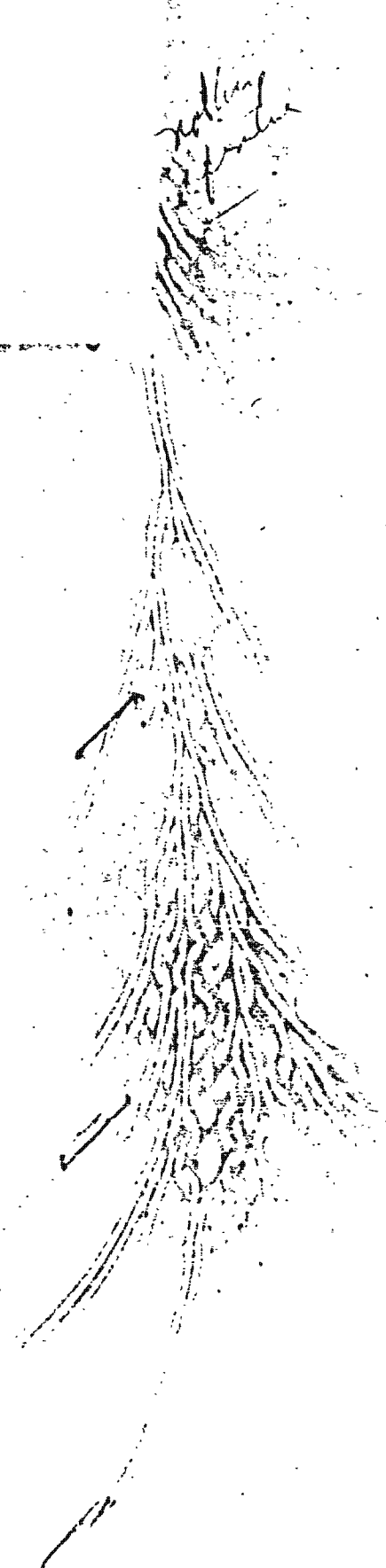

Lamberto BESTA

April 1955 : Resident of Milan at Via Teodosio 23, collaborated for  
brief period with <sup>Demigod</sup> ~~Demigod~~ regarding clandestine  
traffic in strategic materials. Lives by trafficking in cigarettes and  
other things - not excluding dope. Also maintains contact with  
head of [redacted] in Italy in political field. Person of  
doubtful honesty, braggart and capable of carrying out any kind of  
activity for money. (Source Demigod)

March 1954: [redacted] service (Min of Int) offered to turn over to [redacted] 15-22  
full control of PIC operation in which BESTA was involved. Hqs warned  
"heads off" because of BESTA's extremely bad reputation - he has been  
implicated in all sorts of contraband traffic as well as reputation  
of completely ~~unanchored~~ unanchored intelligence operator.

Nov 1953: He was an attempted double agent operation by [redacted] into  
Yugo I.S.
