1. It was Headquarters understanding that the transfer of MIGNOTTI's personal furniture to LICKEY-1 was going to be arranged as a matter between the persons concerned. The contractual arrangements between ABLAKE and LICKEY-1 did not cover or contemplate furnishing of household items.

2. Reference A indicates that the Station purchased the items listed therein from MIGNOTTI and furnished them to LICKEY-1 as of furniture. It is assumed that when the contract with LICKEY-1 is terminated the furniture will revert to Station stocks for future use.

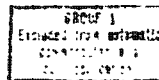
