The following report is one of a series containing personality information provided by the source and includes supplemental information from the records of this Agency.

- 1. Gustavo LNU, aka "Lino," is an official of the Departamento Ilegal (Illegal Department) in the Direction General de Inteligencia (General Directorate of Intelligence - DGI).
- Gustavo LNU is a Cuban citizen and was born about 1937 or 1938. He is six feet tall, weighs 140 pounds, had has a thin build. Gustavo's ethnic type is Latin; he has a dark complexion, baack, wavy hair which he wears in a ducktail, small, black eyes, thick eyebrows, a thin, straight nose, a large, thin face, and a long thin neck. He has thin lips and a small mouth which appears to be disfigured when he talks and laughs. Gustavo resides at Calle 20 de Mayo, number 428, Apto 74, Habana.
