When source joined the Inspector General de Inteligencia (General Directorate of Intelligence - DGI), fnu RENAN was working at the headquarters building. When the NA Department was in existence, he was chief of Bureau No. 2. RENAN was also, at one time, the desk officer for El Salvador in the Seccion Central (Central American Section) of the Departamento de Liberacion Nacional - LN) in the DGI.1
