The following report is one of a series containing personality information provided by the source and includes supplemental information from the records of this Agency.

It is requested that the addressees take no action on any of the individuals mentioned in the personality reports without first checking with this Agency.

1. Source knew "Pelencho," whose true name he was unable to recall, as a member of the Departamento de Seguridad del Estado (Department of State Security - DSE). He was a good friend of Norberto HERNANDEZ Curbelo (see CSCI-316/01239-64, 12 October 1964).

2. "Pelencho" was born between 1935 and 1940, is five feet six inches tall, weighs 135 pounds, and has a slim build.
