1. REGRET THAT IT NOT YET POSSIBLE TO GIVE DEFINITE STATEMENT AS TO ~~DEFECTOR~~ SURFACING. FORMAL RESPONSE PER REF B MUST FIRST COME FROM MEXI GOVT, AND THEN FINAL DECISION AS TO SURFACING (INCLUDING MANNER OF PRESENTATION) WILL BE MADE BY ~~DEFECTOR~~ HERE.

2. PER PARA THREE REF A, NAMES OF GUERRILLA WARFARE TRAINEES WILL NOT BE SURFACED IN DRAFT OAS PAPER. SOME OF THESE MIGHT, HOWEVER, COME UP DURING VERBAL PRESENTATION (IF MADE) OF ~~DEFECTOR~~ HIMSELF BEFORE OAS, BUT IN ANY CASE THERE WILL NOT BE ANY LISTING OF THE NAMES OF THE TRAINEES THAT WOULD APPEAR IN THE PAPER.

3. PER STATION REQUEST PARA FOUR REF A, WE WILL DELETE THE ~~Target~~ AND ~~Target~~ CASE FILES. HOWEVER, MENTION IS MADE IN PASSING OF ~~asset~~ IN THE ~~Target~~ CASE FILE AND WE DO NOT BELIEVE THAT WE SHOULD TAMPER WITH THAT FILE.
