AS CF 29 MARCH 1965, THE MOVIMIENTO INSURRECTIONAL DE RECUPERACION REVELUCIONARIA (MIRR, INSURRECTIONAL MOVEMENT FOR REVOLUTIONARY RECOVERY), LED BY CREANDO BOSCH AVILA, HAD COLLECTED \$22,000 IN PUERTO RICO AND PLANNED TO BOMB AN UNIDENTIFIED SUGAR REFINERY IN CUBA. AFTER THE MIRR CARRIES OUT THIS OPERATION, IT PLANS TO CALL A PRESS CONFERENCE AND ANHOUNCE THE FORMATION OF A GOVERNMENT IN ARMS WHICH WILL POSSIBLY BE REPRESENTED BY BOSCH HIMSELF. SUCH A GOVERNMENT IS TO BE RECOGNIZED BY THE DOMINICAN REPUBLIC.

2. ON SO MARCH, VIRGILIO PEREZ TOLD FORMER CUSAM PRESIDENT.
